- 2. Welcome & Introductions meeting called to order at 5:30 pm
- 3. Program Updates
  - a. Business (Melissa) numbers are good, DECA is doing great with 32 state qualifiers. (Kevin) Senior showcase is coming up in mid-January; Leadership is fine. (John) CTSO will be TSA, working with Aubrey to get started.
  - b. STEM (Sam) Digital Electronics doing some soldering, expression design, k-mapping, etc. Engineering is working on an emergency kit design project. AP Computer response questions and with Java. (Aubrey) Computer coding with scratch working into Python; Bio-med are currently working on outbreak projects and after break will be in the forensic science.
  - c. Media (Doug) sharing semester classes with Sam. Emmy's coming up but deadline has been bumped up and we only have one game (which is next week) for recording. Woods is building a studio for Production class. VR class will take around 3 years to hit the sweet spot and be rolling, exploring with ChatGPI. Skills USA will be coming up next month for the students.
  - d. Metals/Woods (Rodrigo) Metals he is learning as he goes along with the students, trying to stay one day ahead of the kids. Woods has a lot of students that want to compete and he can only take 5.
  - e. Agriculture (Rob) Plant Science is growing herbs, doing a compost project with culinary/foods, the main planting will take place in January and currently doing a greenery project for the holiday season. Animal Science working on skeletal anatomy and dissection coming up. Biology and Physical Sci in Ag working on labs and prepared public speeches. FFA has 40+ members already done potato judging and meat evaluations which students won meat as prizes. Just finished Operation Gratitude Project providing 57 total packs for veterans/active duty. Employment skills are coming up.





f. Family Consumer Science (Altaira) – Numbers are great. Foods & Nutrition they are collaborating with Rob (Ag) which has been successful. Early Childhood Education – first round of babies done and went well. January 18<sup>th</sup> students will start a rotation with the preschool. FCCLA – Jan 18<sup>th</sup> is regionals with 12 competing in 7 events. Everyone qualifies for state only 2 can go to Nationals from the entire state. (Jill) Culinary – working on serv safe certs so a lot of information being thrown at the students, labs going each week and have field trips set up to the Culinary College at SCC and a trip to LCSC.

Note: PLC time we are really working on collaborating together intermixing our programs.

    - ii. Melissa mentioned maybe doing a capstone project sharing knowledge they learned from the combined programs.
- 9. Dual Credit Currently offering 8 dual credit courses. We have a three year goal to offer at least one dual credit course per program. Currently working with Walla Walla but looking into articulating with Spokane Community Colleges and Bellevue.








## Enrollment for 2023 - 2024 School Year
